ABBREVIATED SUMMARY OF CLUB RULES

GUEST RULES

- 1. Guests must be accompanied at the Club by a member. Members are responsible for the conduct of their guests and ensuring that their guests follow all applicable dress codes and rules. This rule also applies to non-family childcare attendants.
- 2. Golf and Tennis guests must be registered at the golf shop or tennis shop before they may use the golf course, tennis courts or swimming pool. Swimming pool guests must be registered at the swimming pool.
- 3. The charges for guests are as follows:

Golf: On Fridays, Saturdays, Sundays and holidays \$125; on all other days \$90. For children under 18 on Fridays, Saturdays, Sundays and holidays \$30; all other days \$20. Golf guest fees include use of the tennis facilities and swimming pool.

A member may bring up to seven guests on Tuesdays, Wednesdays and Thursdays, provided that the member has received advance approval from the Starter and/or golf staff for groups of guests exceeding three. A member may bring a maximum of three guests on Fridays, Saturdays, or Sundays.

In no event may a member have more than one guest in a group before noon on Saturdays, Sundays, and holidays.

All guests must play in a group with a member unless approved beforehand by the Starter and/or golf staff.

Tennis: On Fridays, Saturdays, Sundays, and holidays \$20 for adults and \$12 for children; on all other days \$10 for both adults and children. Tennis guest fees include use of the swimming pool. Tournament guests are allowed to play the same day as their match without an additional fee.

Swimming: \$20 for adults and children 12 and older, \$15 for children under 12.

- 4. The same individual may not be introduced as a guest for the use of the Golf, Tennis or Pool facilities on more than one day in any consecutive 30-day period unless the following exceptions apply:
 - Such guest may in addition participate in any and all member-guest tournament or tournaments which shall take place during such thirty-day period.
 - Out-of-town guests of a member over a weekend may play golf or tennis, or both, with such member during all days of such weekend.
- 5. Grandchildren of members who are aged 12 and under and live locally may be introduced as a guest on two weekend days per month and two weekdays during any consecutive 30-day

- period. The standard guest policies apply to grandchildren of members who are above 12 years of age.
- 6. Parents and children of members (who are no longer eligible to be considered members under the family membership), if they themselves are not members, fall within the category of guests.
- 7. The General Manager shall be consulted before large parties (in excess of 12 people) are planned for any activities at the Club, including dining.

HOUSE & GROUND RULES

Health and Safety

- 1. The health and safety of our members, guests, and staff is paramount. All members and visitors to the Club shall be required to comply with all health and safety protocols adopted by the Board of Governors.
- 2. The Club has a lightning detection system that sounds a warning siren when lightning is detected in the area. When the siren sounds, all golf, tennis and pool activities must stop and everyone should seek appropriate shelter until the "all clear" is sounded. If the lightning alarm siren is not sounded, members and their guests should exercise good judgment in determining whether to seek shelter.

Technology

- 1. When on Club premises, phones should be set on "vibrate" or "silent." If you must make or take a call, please use designated areas where cell phone use is permitted. These areas include inside the foyer coat room, the parking lots, the card room (if not otherwise in use), the pool locker rooms, and by the back fence at the Large Pool (signs will be posted).
- 2. Laptops, tablets and other devices may be used without audio to quietly "work from the Club" in specified areas, including the East Terrace on weekdays, between tennis courts 6 and 7, and by the Pool. Please be respectful of others in these areas, in particular to the members playing tennis.
- 3. You may take audio/zoom meetings using headphones only on the East Terrace (if not otherwise in use) and in the Grill Room so long as calls are kept to a respectful volume.

Children at the Club

1. Adults have priority over children in all areas of the Club, including the Clubhouse and locker rooms.

- 2. Children 5 years of age and older are permitted to use the Clubhouse dining facilities with their families, except on Saturday evenings unless it is a designated family event. Children must conform to adult standards of behavior and dress unless specified above.
- 3. During inclement weather, or when alternate dining facilities are not open, families or groups with children under 5 are welcome to use the Clubhouse dining facilities. Families or groups with children under 5 may be asked to dine on the East Terrace or in areas designated for family dining.
- 4. Children under 12 shall not be in any adult locker room unaccompanied at any time. Children under 12 who are accompanied by an adult may use the women's and men's locker rooms ONLY on Sunday and holiday evenings between 3:00 p.m. and 6:00 p.m. Children 5 years of age and older are never permitted in the locker rooms of the opposite sex.
- 5. The restrooms in the first floor hallway are available for family use during regular Clubhouse hours. Additionally, there are family friendly restrooms at Dom's (11th tee), the Pool and the Tennis house.
- 6. Children under 12 years old, who are traveling to different areas of the Club, must be accompanied by an adult.
- 7. Children are prohibited on the putting green and chipping areas during dining events.
- 8. Strollers are not permitted at any time in the Clubhouse or on either terrace, except during family dining. They shall otherwise be stored in the coatroom.

Club Environment and Reservations

- 1. Smoking or vaping of any kind is strictly prohibited in or around the Clubhouse (including on all terraces), on the driving range, on the putting green or at the golf practice facilities, on the tennis/paddle courts and in the Pool area.
- 2. Reservations must be made 24 hours before an event online or before the office closes the day before the event. Reservations made after that time are subject to management approval and may not be accepted depending on space and staffing.
- 3. Cancellations must be made 24 hours before an event online or by the time the office closes the night before the event. Untimely cancellations or failure to show up for a reservation shall be subject to a 50% cancellation charge.
- 4. Clubhouse facilities are not available after midnight, except for during designated special events.
- 5. Tipping of employees, other than locker room attendants, is strictly prohibited and will be subject to disciplinary action by the Executive Committee.
- 6. Members using the tennis courts or golf course will be charged the yearly rental fee for a locker, regardless of frequency of use.
- 7. Dogs are not permitted on Club grounds at any time.

8. Vehicles must:

- a) yield to all golfers and pedestrians in the driveway and parking areas;
- b) not sit idle or stand in front of the Clubhouse or in the driveway;
- c) not exceed a speed of 10 mph on Club grounds; and
- d) be locked when parked in the parking lot at all times.
- 9. All complaints shall be addressed to the General Manager or to the appropriate Committee Chair, who in turn shall refer such complaints to the Officers of the Club. IN NO CASE SHALL AN EMPLOYEE BE REPRIMANDED DIRECTLY BY A MEMBER OR GUEST.

If a complaint is made about a member breaking a house rule, a Committee Chair will verbally contact the member to discuss the infraction. If a second complaint occurs, a letter of misconduct will be sent to the member. A third complaint will be reviewed by the Executive Committee and may result in further disciplinary action.
